Data processing is done manually, in compliance with legal requirements and conditions that ensure the security , confidentiality and the rights of the holders of personal data.

Data processing is governed by the following principles:

### Notification .

Personal data operator notified The National Supervisory Authority For Personal Data Processing, with the notification number : 676587228762 Processing of personal data is based on and in accordance with the Romanian law.

### The purpose of legitimate interest.

Any processing of personal data is made with clear purpose, explicit and legitimate, appropriate, relevant and not excessive in relation to the purpose for which the data is collected .

### Confidentiality .

Personal Data are processed and used according to the privacy policy statement and will not be used in any way contrary to this policy , the information collected is used only for the purposes for which they are collected.

Consent of the person concerned.

Any processing of personal data , except for the processing of the data from some categories strictly mentioned by Law 677/2001, can be performed only if the data subject has given express and unequivocal consent of that processing.

### Information .

The Information of the personal data processing shall be made by the institution that processes personal data towards any person concerned. Protecting subjects.

Data subjects have the right of access the data that are processed, to intervene, to express opposition, and have the right to apply to the National Supervisory Authority for Personal Data Processing Security or in Court to defend their rights guaranteed by law, such rights have been violated. Appropriate technical and organizational security of personal data are established to protect personal data against accidental or unlawful destruction , loss , alteration , unauthorized disclosure or access (access to user databases is based on user name and password system, controlled by the administrator of MEDIA EXPRES SRL) . The possibility of alteration of data accessed is protected by firewall and antivirus solutions.

### HOLDER OF PERSONAL DATA RIGHTS

(regulated by Law 677/2001 , with subsequent amendments)

- The right to obtain from MEDIA EXPRES SRL, upon request and free of charge to one request per year, confirming that your personal data are processed or not by MEDIA EXPRES SRL;
- The right to obtain from MEDIA EXPRES SRL, upon request and free of charge rectification, updating , blocking or deletion of data whose processing does not comply with the Law 677/2001, in particular incomplete or inaccurate data ;
- The right to obtain from MEDIA EXPRES SRL, upon request and free of charge the transformation in anonymous data whose data that does not comply with the Law 677/2001 ;
- The right to object at any time, for legitimate reasons, the data related to you to be processed, except where there are legal regulations, or in case of justified reasons the respective data can not be processed;
- The right to go to court to defend the rights guaranteed by the Law 677/2001, provided such as rights have been violated;
- To claim violation of rights guaranteed by the Law 677/2001 with subsequent amendments , please contact the The National Supervisory Authority For Personal Data Processing and / or courts.
